## Group 1 – Primary Photo

- Passport (current or expired by less than 2 years – not cancelled). Australian or Foreign Passport with English translation (if not in English).
- Licence – Current Australian or Foreign with English translation (if not in English). Renewed, Provisional, Driver's, Truck or Learners. Other acceptable Government issued licences for the purpose of driving a vehicle includes a Pilot's licence issued by CASA.
- Photo ID Card /Proof of Age Card/ Birth Card (NSW) – (Issued by a Government Department).
- Travel Document – documentation of identity – Current Australian or Foreign with Visa with English translation (if not in English) – issued by official sources for the purpose of Travel, e.g. United Nations (UN).

Must contain individual's full name and either residential address (PO Box not allowed) and/or date of birth.

## Group 2 – Primary Non-Photo

- Birth Certificate or Birth Extract (Australian original) – Foreign Birth Certificate with English Translation (if not in English).
- Citizenship Certificate – Australian or Foreign with English translation (if not in English).
- Pension Concession Card or Government Health Care Card (Document reference number required).

Must contain individual's full name and either residential address (PO Box not allowed) and/or date of birth.

## Group 3 – Secondary

- Notice issued by a Commonwealth, State or Territory Department. Notice of Financial Benefit less than 12 months old (e.g. Centrelink statement).
- Notice issued by the Australian Taxation Office – Notice of debt or assessment less than 12 months old.
- Notice issued by a Local Government Body or Utilities Provider (e.g. Council Rates, Water Rates, Electricity Bill, Gas Bill and Telephone (Landline) Bill – less than 3 months old).

Must be on account/ letterhead and show individual's name and residential address.

## Group 4 – Alternate Secondary. Can only be used with Group 1

- Australian Financial Institution issued Credit Card, Debit/ATM Card – Current.
- Medicare Card – Current.
- Student ID Card – Current issued by Secondary or Tertiary Institution.

Must contain individual's name and a document reference number.

## Special Provisions – Child under 18 years

- Birth Certificate/Birth Card/Passport/Citizenship Certificate/Proof of Age Card/Photo ID Card/Letter from Principal – less than 3 months old.

Must contain individual's full name and either residential address (PO Box not allowed) and/or date of birth.

## Recent Arrivals in Australia (less than 6 weeks)

- Passport (current or expired within the last 2 years, not cancelled).
- Travel Document – documentation of identity – Current Australian or Foreign with Visa with English translation (if not in English) – issued by official sources for the purpose of Travel, e.g. United Nations (UN).

Must contain individual's full name and either residential address (PO Box not allowed) and/or date of birth.

**Note: Certifiers are to certify legible copies of two documents provided from the above documents listed and also provide certifier details on reverse of this form.**

  8. An Australian consular officer or an Australian diplomatic officer (within the meaning of the Consular Fees Act 1955).
  9. A member of the Institute of Chartered Accountants in Australia, CPA Australia or the National Institute of Accountants with two or more years of continuous membership.
  10. An officer with two or more years of continuous service with one or more financial institutions (for the purposes of the Statutory Declaration Regulations 1993).
  11. A Justice of the Peace.
  12. An agent of the Australian Postal Corporation who is in charge of an office supplying postal services to the public.
  13. A permanent employee of the Australian Postal Corporation with two or more years of continuous service who is employed in an office supplying postal services to the public.
  14. A finance company officer with two or more years of continuous service with one or more finance companies (for the purposes of the Statutory Declaration Regulations 1993).
  15. An officer with, or authorised representative of, a holder of an Australian financial services licence, having two or more years of continuous service with one or more licensees.
  16. Any person specifically appointed as our agent to certify identity.
- Note: Non-residents – certification by the following acceptable certifiers – categories numbered 1, 2, 3, 4, 5, 6, 7, 8, 9 and 10 as equivalent within the certifier's country of residence.
